

## Cov Kev Pab Rau Xiam Oob Khab (*Disability*) & So Rau Kev Muaj Mob Ib Qho Qhia Rau Cov Neeg Ua Num

Daim ntawv no yog daim ntawv qhia txog kev pab yog koj muaj kev nyuaj ntawm haujlwm txheeb rau kev xiam oob khab los muaj mob loj. Piv txwv, tej zaum koj muaj:

- muaj mob loj heev thiab yuav tau so ntev (kho)
- rov qab tuaj ua num tiam sis ua tsis taus num qub tom qab raug mob los mob zoo rov tuaj
- muaj xiam oob khab uas txwv koj ua koj txoj haujlwm tsis tau li qub

Daim ntawv no qhia txog kev ua raws thiab cov kev muaj pab. Peb cia siab tias nws yuav pab koj to taub cov kev muaj rau koj xaiv, kawm seb yuav muab tau ntaub ntawv ntxiv li cas, thiab yuav nrog leej twg tham yog xav tau kev pab.

### Cov Xyuas Kev Pab Rau Xiam Oob Khab {*Divisional Disability Representatives (DDRs)*}

Koj tus *dean/director* tau xaiv tus neeg Sawv Cev Pab Rau Xiam Oob Khab kom muaj kev pab kom koj ua tau num thiab/los thaum rov tuaj ua haujlwm. Cov *DDR* tau kawm tas txog kev ua raws pab neeg muaj kev xiam oob khab thiab tau cai muab tau, txais thiab khaws cov ntaub ntawv txog kev muaj mob tsis pub leej twg paub ntawm ceg ua num. Koj hu tau rau koj tus *DDR* tham tsis pub leej twg paub yog koj muaj kev nyuaj ua tsis tau num vim muaj kev xiam oob khab los muaj mob loj, los yuav tau mus so vim muaj mob.

Ib qho kev pab kom ua tau num yog tej Yam pauv los hloov rau txoj haujlwm, thaj chaw ua num, los kev ua txoj num kom cov neeg muaj kev xiam oob khab muaj peev xwm ua tau txoj num tso tau npe rau, ua tau cov haujlwm, thiab tau kev pab thiab nyiam txoj haujlwm xws li cov tsis muaj kev xiam oob khab, uas tsis muaj kev puas nyuaj ntawm qhov chaw ua num los tsis muaj puas kev noj qab haus huv los nyab xeeb.

### FMLA/WFMLA (Kev so vim tsev neeg los tus kheej muaj mob)

Nom tswv Asmeslikas tus cai *Family & Medical Leave Act (FMLA)* thiab Wisconsin tus cai *Family & Medical Leave Act (WFMLA)* yog muaj kev pub neeg ua num so tsis pub poob txoj haujlwm vim tsev neeg thiab/los tus neeg ua haujlwm muaj mob.

*FMLA/WFMLA* pub koj so tsis them nyiaj, tabsis koj siv tau cov caij so rau kev muaj mob los lwm yam caij so uas koj tshuav rau lub caij koj siv qhov *FMLA/WFMLA*.

## **Nyiaj Them Raug Mob Ntawm Haujlwm (*Worker's Compensation*)**

Nyiaj them raug mob ntawm haujlwm yog ib qho “tsis yog yus txhaum” kev ua tsis taus haujlwm los xiam oob khab thaum tus neeg ua num raug mob los mob ntawm haujlwm.

Yog koj raug mob los kis kab mob nyob ntawm haujlwm, thov qhia rau koj tus thawjsaib sai li sai tau. Qhov no yog ib qho tseeb txawm tias koj qhov raug mob los mob me me xwb thiab tsis tau mus ntsib kws kho mob. Rau kev pib ua ntaub ntawv rau nyiaj raug mob, thov teev daim ntawv *Employee's Work Injury & Illness Report* thiab xa rau koj tus thawjsaib.

## **Caij Pub Rau Kev Muaj Mob Loj/Nyhav (*Catastrophic Leave*)**

Caij pub rau muaj mob loj ua kom ib tub neeg tau nyiaj them thiab lwm yam kev pab thaum nws muaj mob loj thiab siv nws cov caij so/mob tag lawm. Qhov no pub cov neeg ua num rau hauv tsev kawm ntawv muab lawv cov caij so mus ua si, caij so rau tus kheej, los *banked leave* (tsis yog caij rau muaj mob los caij ua tshaj xuab moos) rau cov neeg ua haujlwm hauv UW-Madison los lwm lub tsev kawm ntawv UW uas muaj mob loj tsis tshuav caij so.

## **Paj kas phais Pov Hwm Kev Muaj Mob/Ua Tsis Tau Haujlwm (*ICI*)**

Paj kas phais pov hwm kev muaj mob los ua tsis tau haujlwm them 75 feem puas ntawm cov nyiaj ua num tau txhua hli thaum koj ua tsis taus haujlwm los xiam oob khab. Nyiaj them tom qab caij xaiv tos (tsawg kawg 30 hnub) loss iv cov *sick leave* (txog 130 hnub), seb qhov twg ntev dua. Nws muaj ob theem them: *Standard ICI* them (75 feem pua) txog \$64,000; *Supplemental ICI* them (75 feem pua) ntawm \$64,001 mus txog \$120,000.

*WRS Disability Retirement 40.63* yog ib qho kev them rau xiam oob khab nyob hauv *Wisconsin Retirement System*. Koj yuav tsum muaj li cov yuav kom muaj koj thiaj tau qhov nyiaj no. Qhov nyiaj them no raws li seb koj ua tau puas tsawg xyoo (*WRS years of services*), nrog cov xyoo ntxiv kom koj txog hnub nyooog noj nyiaj (65 xyoos) thiab peb xyoos koj tau nyiaj ua haujlwm ntawm tshaj.

*Duty Disability (40.65)* yog ib qho kev them nyiaj rau kev xiam oob khab nyob hauv *Wisconsin Retirement System* rau cov ua num rau kev ceev xwm (ntawm *UW-Madison: UWPD*). Yog koj ua haujlwm rau kev ceev xwm thiab xiam oob khab thaum ua haujlwm tej zaum koj yauv tau qhov nyiaj *Duty Disability*.
